

MONONA COUNTY DELINQUENT TAX LIST

I, Laura Oliver, Treasurer of Monona County, Iowa, hereby give notice that the Annual Tax Sale will be held in the Monona County Treasurer's Office on the first floor of the Monona County Courthouse, 610 Iowa Ave., Onawa, IA on Monday, the 17th day of June, at nine o'clock a.m. This will not be an in-house auction, but will be held live online. Bidders need not be present at the courthouse but must register at <https://www.iowataxauction.com>.

All bids must be placed online. Registered bidders can access the auction site by going to <https://www.iowataxauction.com>. I will, as required by law, offer to the public at tax sale the following described real estate, mobile homes, and special assessments, which at the time of the sale remain delinquent and unpaid.

Bidder information may be obtained by contacting the Monona County Treasurer's Office at the address and phone number listed below. Interested bidders are required to complete and submit the necessary bidder information online by 11:59 p.m., Thursday, June 13, 2019. An adjourned tax sale will be held any business day following the annual tax sale in which there are bidders present and parcels are still available for sale.

Any tax payer affected may avoid tax sale proceedings by making payment of the amount shown to the Monona County Treasurer by 4:00 p.m. on Thursday, June 13, 2019 by cash or money order only. Property taxes may also be paid online at www.iowatreasurers.org through Thursday, June 13, 2019 at 11:59 p.m.

Public bidder parcels are parcels that have been previously advertised without sale. If no bid is received on public bidder parcels, Monna County shall obtain a tax sale certificate for the property.

When a parcel is purchased at tax sale and is not redeemed within the period provided in Chapter 447 of the Code of Iowa, the right to redeem expires and a deed may be issued. In addition to the normal tax sale proceedings, the County Treasurer may bring or cause an ordinary suit at law to be commenced and prosecuted in the Treasurer's name for the use and benefit of the County for the collection of taxes, and the suit shall be in all respects commenced, tried and prosecuted to final judgment the same as provided for ordinary actions.
