I, Abby Riesberg, Treasurer of Monona County, Iowa, hereby give notice that the 2026 annual Tax Sale will be held at 9:00 am on Monday, June 15, 2026, in the Treasurer's office on the first floor of the Monona County Courthouse, 610 Iowa Ave, Onawa, Iowa. All bids must be placed online. The auction site can be accessed by going to [www.GovEase.com](http://www.GovEase.com). I will, as required by law, offer to the public at tax sale the following described real estate, mobile homes, and special assessments, which at the time of the sale remain delinquent and unpaid.

An adjourned tax sale will be held on any business day following the annual tax sale in which there are bidders present and there are parcels still available for sale.

Public bidder parcels are parcels that have been previously advertised without sale. If no bid is received on public bidder parcels, Monona County shall obtain a tax sale certificate for the property.

To be eligible to bid at the Monona County Tax Sale, all tax sale bidders must complete and submit the necessary bidder information online at [www.GovEase.com](http://www.GovEase.com) by 11:59 p.m., Thursday, June 11, 2026.

Any taxpayer affected may avoid Tax Sale proceedings by making payment of the amount shown to the Monona County Treasurer in **CERTIFIED FUNDS; CASH, CASHIERS CHECK, OR MONEY ORDER BY 4:00 P.M. ON FRIDAY, JUNE 12, 2026. ONLINE PAYMENTS CAN BE MADE AT [www.IowaTreasurers.org](http://www.IowaTreasurers.org) UNTIL MONDAY JUNE 8, 2026 AT 11:59 P.M.**

When a parcel is purchased at tax sale and is not redeemed within the period provided in Chapter 447 of the Code of Iowa, the right to redeem expires and a deed may be issued. In addition to the normal tax sale proceedings, the County Treasurer may bring or cause an ordinary suit at law to be commenced and prosecuted in the Treasurer's name for the use and benefit of the County for the collection of taxes, and the suit shall be in all respects commenced, tried and prosecuted to final judgment the same as provided for ordinary actions.
