Interested bidders will need to complete and submit the required bidder information by 11:59 p.m. on Thursday, June 13th, 2019 in order to bid at the online tax sale. After the sale, for parcels that are sold, if the parcel is not redeemed within the period provided in Iowa Code Chapter 447 - Tax Redemption, the right to redeem expires and a deed may be issued.
