

WASHINGTON COUNTY TREASURER'S PUBLIC NOTICE

Annual Tax Sale

I, Jeffrey A. Garrett, Treasurer of Washington County, Iowa, do hereby give notice as required by Iowa law, that on the third Monday of June at 10:00 a.m., the date being June 17, 2019, at the Washington County Courthouse, I will offer for sale all parcels for which taxes are delinquent for any period and sell those properties indicated with an 'S' which were previously advertised for one year or more and not sold, as required by Chapter 446, Code of Iowa. All parcels remaining unsold on the sale date will be offered at adjourned tax sales held on the third Monday of each month, or the following workday, at 10:00 a.m. in the office of the Washington County Treasurer, commencing July 15, 2019, until the next regular annual sale, or until all taxes are paid.

Those wishing to bid at the annual tax sale must register online at www.iowataxauction.com by June 12, 2019. Registrations will not be accepted after that date. After the sale, if the parcel sold is not redeemed within the period provided in Chapter 447, the right to redeem expires and a deed may be issued.

The sale shall be made for the total amount of taxes, special assessments, interest, and service fees due. Any commencement of court action, authorized by law for collection of all other taxes, shall commence ten days after publication of this notice. This notice and delinquent parcel listing will appear once on June 6, 2019, and will show the name of the person to whom taxed, a description of the parcel, the item number, the district, the parcel number, and the amount of taxes, special assessments, interests, and service fees, all incorporated as a single sum.

Properties for which a notice of bankruptcy is on file are indicated with a 'B' and will be withheld from the sale. Any listing contained herein for which a notice of bankruptcy or suspension is received after publication will also be withheld from sale. Any person listed below that is a recipient of SSI or SSA is advised to immediately contact the County Treasurer's Office at (319) 653-7721. Any publication errors or irregularities do not affect the legality of the tax sale.
